

RULES FOR THE SHSAA, INC.

NATIONAL MEMBERSHIP DRIVE CONTEST, 2010

The National Membership Drive will begin October 1st.

Using the Membership Form (see attached), recruit individuals to join the National Chapter of the organization. Make sure that you write your name at the top of each Membership Form that you give out so that the number of people that you recruit will be able to be tallied accurately. No member will be attributed to you if your name is not on the Membership Form that is received by the National Financial Secretary. Make enough copies of the blank form for distribution. Please have a physical address and/or an e-mail address on all Membership Forms. Members cannot receive mailings for voting or other communications unless a proper address is submitted to the National Financial Secretary.

Tell all of your recruits that their National membership dues of **\$20.00** must be in to the National Financial Secretary, Angela Davis-McCoy, no later than November 30, 2010. Membership forms that are mailed in must be postmarked on, or before **November 30th, no exceptions**. The forms may be submitted to Mrs. Angela Davis-McCoy directly (address is on form), or they may be submitted to the appropriate person within your local chapter (Financial Secretary or Membership Chairperson) for submittal to the National Financial Secretary. However, no matter who submits the Membership Form/s along with the Membership Dues, they both **must** be sent to the National Financial Secretary with a postmark that is on **or** before **November 30th**.

Eligibility for the grand and second place prizes requires that you recruit **at least 5 members**.

The person who recruits the most National members will receive a prize of **\$75.00**.

The person who recruits the second most National members will receive a prize of **\$50.00**.

Winners will be announced on December 10th.
